Letter of compliance – Australian Defence Force Superannuation Scheme (ADF Super)

This notice certifies that ADF Super is a complying superannuation fund which can accept superannuation contributions (including employer, salary sacrifice and personal after-tax) and rollovers for eligible persons. It also provides information regarding your account.

Complying fund confirmation

ADF Super is established under the *Superannuation Act 2005*, Trust Deed and Rules. It is a resident regulated superannuation fund (RSE Licence No. R1077063) within the meaning of the *Superannuation Industry (Supervision) Act 1993* (SIS Act) and is not subject to a direction under section 63 of the SIS Act (can accept employer contributions) by the Australian Prudential Regulation Authority (APRA).

ADF Super is managed by the Commonwealth Superannuation Corporation (CSC). CSC is licensed under the *Corporations Act 2011* and regulated by the *Superannuation Industry (Supervision) Act 1993*. CSC is responsible for all aspects of ADF Super, including investment strategy, administration and member communications.

For the purpose of rolling over funds from another fund to ADF Super, the ADF Super ABN is 90 302 247 344 and the USI is 90302247344001. Rollovers can be made by completing the **Transfer form** available on adfsuper.gov.au or by contacting the fund you would like to transfer super from. Eligible members can gain secure access to their account to view and update details, select investment options and make contributions to the fund by setting up an **online member login** available on adfsuper.gov.au

For employers

Eligible employers can also set up a secure online account to make superannuation guarantee contributions to member accounts by setting up an **online employer login** available from our Employer Centre on csc.gov.au
